IV infusion must be administered by a health care professional only and is given as an induction therapy for the treatment of Crohn's disease and Ulcerative colitis.

Select common adverse reactions include: Psoriasis: nasopharyngitis, upper respiratory tract infection, headache and fatigue; Crohn's Disease, induction: vomiting; Crohn's Disease, maintenance: nasopharyngitis, injection site erythema, vulvovaginal candidiasis/mycotic infection, bronchitis, pruritus, urinary tract infection and sinusitis; Ulcerative colitis, induction: nasopharyngitis; Ulcerative colitis, maintenance: nasopharyngitis, headache, abdominal pain, influenza, fever, diarrhea, sinusitis, fatigue and nausea.

Biologics/biosimilars come in branded and unbranded products. Since branded and unbranded biologics/biosimilars share the same biologics license application (BLA), they may be changed with the corresponding unbranded or branded biosimilar as deemed by the prescription benefit plan.
